TERMS OF AGREEMENT:

- I/We agree to pay fees as specified above. I/We understand that the deposit for each camp (\$30.00) will be applied toward the fees for that camp. ALL CAMP FEES ARE NON-REFUNDABLE. No financial adjustment will be made for illness, absence or holidays occurring during the session.
- The session fee for each camp must be paid in full at the school office 1 week prior to camp start date. Fees once paid are NON-REFUNDABLE. If fees are not paid in full by the payment deadline, your child will lose his/her reservation for that camp. Fees paid after the deadline will incur a \$10.00 late fee. Please refer to the payment schedule for each session.
- Student Accident Medical Insurance is covered by CTCS.
- Delinquent and/or Returned Checks: a \$30.00 late fee will be assessed for each returned check. Replacement payments must be paid by cash or money order. After the second returned check, CTCS will require all future payments to be made in cash or by money order.
- Overtime: \$1.00 for every minute before or after your child's contracted time of care. The building closes at 6:00PM. In the event that the Parent/Guardian has not picked up the student or contacted the school by 6:30PM, the San Diego Police Department may be called to pick up the child.
- The Parent/Guardian agrees to release and hold harmless First Presbyterian Church of San Diego, City Tree Christian School, their agents, employees, consultants and independent contractors from all claims, damages or other liabilities for injuries to their student which are not the result of gross negligence by the school, its agents or employees. The Parent/Guardian agrees to reimburse City Tree Christian School for damages caused by their student.
- CTCS reserves the right to dismiss or expel any student for cause as outlined in the parent handbook.
- Applicable Law: This agreement shall be deemed to have been entered into in the State of California and its validity, effect and operation shall be determined according to California law.
